<b>Advisory vote on the host city for the World Congress 2018</b>		
Rome: 24	Nijmegen: 10	
The IAPSS Executive Committee will consider the options starting from the more popular one based on the vote, and having in mind the effort to set as low registration costs as possible and organize its main annual event in a city as affordable as possible.
