

# About: The World Congress

#### On the theme

The digital era has revolutionized the way societies function, communicate, and are governed. The integration of technology into governance processes has shown the potential to enhance efficiency, transparency, and citizen engagement. Although the rate of adoption of digital tools among governments has been slow at first, the growing accessibility of mobile Internet, and notably the COVID-19 pandemic, have forced government transformation to adapt to the digital era. Governments have taken notice of how digital tools help to accelerate operations and optimize resources, allowing for a more effective allocation of public funds. Governmental entities started making use of data-driven decision-making as the ability to collect and analyze vast amounts of data empowered them to make informed decisions based on evidence and trends.

However, the high pace of progress of digital technologies presents challenges to governance. Crucial questions about privacy, security, and the equitable distribution of digital resources have been posed, while the recent developments in the field of Artificial Intelligence (AI) have raised concerns about the risks created by the growing accessibility to AI models. The governments-signatories to The Bletchley Declaration have highlighted that "many risks arising from AI are inherently international in nature, and so are best addressed through international cooperation". As we navigate through an increasingly interconnected and technologically driven global landscape, the future of governance faces unprecedented challenges and opportunities.

There are many implications of the digital era on issues such as human rights, privacy, and the rule of law. How do digital advancements affect the balance between security and civil liberties? What challenges emerge in ensuring ethical governance in the face of rapid technological change? How are developing nations navigating the challenges posed by digitalization? How do advancements in technology impact the security of government systems and citizens' personal data?

# Keynote Speech

#### SECURITY AND NEW TECHNOLOGIES

Dr Triantafyllos Karatrantos, Senior Research Fellow, Radicalisation, Terrorism, Policing Models, Security and Foreign Policy, Hellenic Foundation for European and Foreign Policy

Dr Triantafyllos Karatrantos is an International Relations, European Security and New Threats expert. He is a Research Fellow in Radicalization, Terrorism, Policing Models, Security and Foreign Policy at the Hellenic Institute for European and Foreign Policy (ELIAMEP) and Senior Advisor on Radicalization, Organized Crime and Terrorism Research and Prevention Policies at the Center for Security Studies (KEMEA). In September 2021, he was appointed by the European Commission to the Advisory Board of Researchers charged with researching and developing the policy for preventing radicalization and countering violent extremism for the RAN – Policy Support.

He is also a postdoctoral researcher on Polarization & the Prevention of Radicalization and Violent Extremism at the National and Kapodistrian University of Athens, and lectures at the National Security School of Greece on Multiculturalism, Migration and Security; Intercultural Policing and Community Policing; and Radicalisation and Terrorism.

He holds a Ph.D. in European Security and New Threats from the University of the Aegean. Since 2014, he has been working at the Center for Security Studies (KEMEA) on training programs and European and research projects. He is also a RAN-certified COE trainer in Radicalization, a member of the RAN LOCAL Group, a CEPOL network expert, and a specialized trainer on polarization, radicalization, multi-agency cooperation and FTF's common identification indicators.

He has published two books with Epikentro Publications and co-edited one with Vasilis Vamvakas and Panagis Panagiotopoulos. He has also contributed seventy-five (75) chapters to collective volumes and journals in Greece and abroad and written, or participated in the writing of, fifteen (15) policy and working papers. Between July 2019 and August 2021, he served as a Security Policy Advisor to the Minister for Citizen Protection. He has been a Security Policy Advisor to the Minister of State since September 2021.

 Plato's Meno: The Problems of Scientific Definitions in Our Understanding of the Political

Néstor Fernando Aranibar Campero, KU Leuven

The first part of Plato's Meno focuses on three failed attempts to define virtue. Each of the attempts is intertwined with a claim for political rule, the classical standard that rule should be performed by the best human beings. Although every attempt to define virtue has its problems and its grains of truth, the third example is most akin to the

problems we deal with in our times in regard to the examination of political phenomena. This workshop will provide a brief introduction to the two previous attempts and a careful reading of the third attempt. In exploring Plato's arguments together, we will gain the tools for a better understanding of political phenomena.

# Information for Panelists

#### Time Structure of Panels

Each paper presentation will consist of a presentation by the paper presenter, the discussant's reply and a Q&A session with the audience.

Panels featuring three panelists will be structured (as per paper presenter) as follows:

- 12 minutes presentation;
- 3 minutes discussion by the discussant;
- 15-minute Q&A with the audience.

Panels featuring four panelists will be structured (as per paper presenter) as follows:

- 10 minutes presentation;
- 2,5 minutes discussion by the discussant;
- 10-minute Q&A with the audience.

All panels are limited to about 90 minutes each.

All paper presenters, discussants and chairs are requested to be at the venue of the panel at least 10 minutes before the panel's opening.

#### PROVIDED TECHNICAL FACILITIES

All rooms are equipped with presentation facilities (fixed data projectors, podium microphones, fixed hearing loop, whiteboards).

You are kindly suggested to prepare a visual presentation underlining your discourse. Please bring your laptop with the respective file(s) to the panel, best if in both .ppt and .pdf file types.

#### How To Be A Good Panelist

- Keep to time. You will be allocated between 10 and 12 minutes (according to the total number of paper presenters in your panel) and if you go over the limit, it will be taken from the time of your co-panelists.
- Structure your presentation so that the audience has the time to ask you questions afterward.

- Prepare your speech beforehand. You do not need to read directly from the paper but hint-cards are always useful.
- If you write down your speech, make sure you have leeway time-wise. Speakers reading directly from the paper very often underestimate the time they will need for presentation.
- If you run out of time, you will be cut off mid-presentation. No exceptions.
- You have the option to use a laptop and a projector to display your figures, charts, or the summary of your paper. Be cautious with its use. Do not merely read what is written behind you that is not presenting. The projector is an addendum, not the core of your presentation.
- Be precise and concise. You are presenting your research results, not making a political speech. Keep in mind that your audience is smart.
- Read the papers of your colleagues. It is polite to prepare at least one question for each of your co-panelist and give them proper feedback. Your work does not end with finishing your paper, the key to a successful academic panel is interaction among its participants.

# Guidelines for Panel Chairs

#### HOW TO BE A GOOD PANEL CHAIR

- You must read the papers in your panel carefully and prepare questions.
- Start your panel exactly on time whenever possible.
- No need to introduce yourself or anyone else at length. At most, say people's names and institutional affiliations. Let them introduce their papers themselves.
- Let the panelists speak in the order listed on the programme unless they request otherwise for technical reasons, for example.
- Keep each panelist to the time allotted. This is the most important part of the role of the panel chair. Divide the entire session evenly between all panelists. If one person goes over the time limit, they are cutting directly into the time of the other panelists, and that must be avoided. Give people a subtle warning when they are close to time by typing out '5 minutes/2 minutes/1 minute' in the chat box. Once they are out of time, give them notice. If they do not stop, you will need to be bold and ask them out loud to wrap up.
- Take questions from the audience immediately after individual presentations.
   The Q&A should comprise at least one third of the time allocated to one panelist. If there are lots of questions, try to avoid asking any yourself, but do try to think of some just in case the audience goes silent too soon.

- Do not allow the audience to go off on a lengthy tangent; you may need to interrupt them to refocus the discussion.
- Make sure the session finishes on time. People will want to take a break and stretch their legs before the next events, and if you want to continue discussing with someone about their research, you can always reach out to them via email.
- Thank the presenters at the end of every presentation.

#### HOW TO GIVE FEEDBACK

Your first and most important responsibility is to <u>help the audience understand the</u> <u>papers better</u>. You must read the papers carefully, take time to understand their contributions, strengths and weaknesses, and what the audience needs to know about them.

Your second responsibility is to the authors. What are your reactions to the papers and why? What can the authors do to improve the paper? Learning how to read other papers with the critical eye of a good discussant will help you to learn how to write papers that appeal to the profession.

Review all papers through the following steps:

- 1. Briefly summarize the main messages, arguments, and the paper's contributions to academia and the wider society.
- 2. Provide an assessment of the paper: does it make its case convincingly and is it academically rigorous?
- 3. Suggest constructive ways to improve the paper.
- 4. Highlight the relevance of the paper to academia and society.
- 5. Stimulate conversation among the audience by posing questions for discussion. During the discussion, you can also draw comparisons between two or more papers presented in your panel.

During the IAPSS World Congress 2024, Chairs are responsible for the Best Panelist Award, presented during the Closing Ceremony to the panelist with the most coherent, structurally-sound, and informative presentation. Chairs are not obliged to recommend a panelist for the award, but your written feedback on the very best of the participating scholars could present someone with the opportunity of winning! Lastly, Chairs may recommend papers for publication at <u>Politikon: The IAPSS Journal of Political Science</u> or <u>Encuentro Latinoamericano: Revista de Ciencia Politica</u>.

#### Awards

The IAPSS Academic Department will give two awards at the end of the Congress.

- Best Panelist Award will be given to a panelist recommended by panel chairs.
- Best Paper Award will be given to a paper author with the best paper as determined by the IAPSS Academic Committee.

The award recipients will be informed of their selection on May 23. Award recipients will have to be at the Closing Ceremony on May 24 to receive their awards.

Registration will begin on the first day at 8:30 am.



The city of Athens has a reliable <u>metro system</u>. If you need to use the bus, we encourage you to download the OASA Telematics app, as Google Maps information is usually inaccurate.

You can use the <u>ATH.ENA ticket</u> for all public transportation options (except for taxis) in Athens. ATH.ENA tickets are rechargeable; there is no need to issue multiple tickets for the duration of your stay in Athens. Tickets can be purchased at the automatic vending machines or ticket countries in metro stations. <u>Bus drivers do not issue tickets</u>.


Should you need to ride a taxi, we recommend downloading the FREE NOW app.


